

CEMETERY RESERVATION AND BURIAL FEES
Effective February 1, 2022

PROCEDURE FOR RESERVING BURIAL PLOT(S):

- Visit the cemetery and select available site(s). (A map is available at the Township Office.)
- Contact the Township office to confirm the selected site is available.
- Complete one (1) reservation form per plot.
- Return form(s) to the Township office together with a check made payable to the Presque Isle Township (PITWP). Once the form and payment are received, a receipt will be issued. **The issued receipt confirms your reservation of the selected plot(s).** (If you do not receive a receipt within 2 weeks, please contact the office.)

PLOT RESERVATION: The fee per plot reservation is \$300.00 for current property owners. Plot reservations will increase in cost \$100.00 the next two Presidential election years of 2024 and 2028 for Township property owners up to \$500.00.

The fee per plot reservation is \$400.00 for former property owners with proof of former ownership.

Plot reservations will increase in cost \$150.00 for former property owners the next two Presidential election years of 2024 and 2028 for former property owners up to \$700.

CREMATION BURIALS: The fee for current property owners is \$150.00 for a cremation burial. The fee will increase \$50.00 for the next two Presidential election years of 2024 and 2028 for Township property owners up to \$250.00.

- *The fee for former property owners is \$200.00 with proof of former property ownership. Cremation burial costs will increase \$100.00 for the next two Presidential election years of 2024 and 2028 for former property owners up to \$400.00*

FULL BURIALS: The fee for current property owners is \$450.00 per full burial. The fee for current property owners will be increased \$50.00 for the next two Presidential election years of 2024 and 2028 up to \$550.00

The fee for former property owners is \$550.00 with proof of former property ownership. The fee for full burials for former property owners will increase \$100.00 for the next two Presidential election years of 2024 and 2028 for former property owners up to \$750.00.

Closure of the cemetery will be from November 1st, through April 1st, depending on the weather and at the discretion of the Sexton.

- All burial fees must be paid prior to the burial or service.
- If additional burial equipment is necessary due to inclement weather, rates may increase.
- Burial spaces shall NOT be opened or closed without the direction and control of the cemetery sexton.
- Grave markers shall NOT be placed without the direction and supervision of the cemetery sexton.
