

**NOTICE OF PUBLIC HEARING FOR SPECIAL ASSESSMENT
PUBLIC IMPROVEMENT OF ROADS
WITHIN PRESQUE ISLE TOWNSHIP**

KAUFFMAN RD. AND KAUFFMAN BLVD PROPOSED SPECIAL ASSESSMENT DISTRICT

TO: The residents and property owners of the following listed existing tax parcels or portions of tax parcels (please see the attached list) fronting, accessing, adjoining, or abutting the following described public roads: the entire length of Kauffman Rd from East Grand Lake Road to Kauffman Blvd. and the entire length of Kauffman Blvd.

TAKE NOTICE that pursuant to the provisions of Act 188, Public Acts of Michigan, 1954, as amended, the Presque Isle Township Board of Trustees has tentatively declared its intention to proceed with the public improvements described as follows: fog sealing, and all work incidental thereto for the entire length of Kauffman Rd from East Grand Lake Road to Kauffman Blvd. and the entire length of Kauffman Blvd.

TAKE FURTHER NOTICE that the Township Board of Trustees has tentatively declared its intention to make such improvements and tentatively designated the above-described lands as a special assessment district against which the cost of said public improvements is to be assessed.

TAKE FURTHER NOTICE that the Township Board of Trustees has caused plans to be prepared showing the public improvements, the location thereof, and an estimate of the cost thereof, which have been filed with the office of the Township Clerk, 12653 E. Grand Lake Road, Presque Isle, Michigan 49777 (989-595-2752), for public examination.

PUBLIC NOTICE IS HEREBY GIVEN that the Presque Isle Township Board of Trustees will meet on Monday, January 13, 2025, at 4:00 p.m., to hear any objections and comments concerning the proposed public improvements and to the proposed special assessment district therefore.

TAKE FURTHER NOTICE that the Township Board of Trustees may determine to proceed to make the proposed public improvements without a petition unless written objections to the proposed public improvements are filed with the Township Board of Trustees at or prior to the

Township Board of Trustees meeting to be held on Monday, January 13, 2025, at 4:00 p.m. If written objections are received from record owners of land constituting more than 20% of the total frontage upon the roads being improved in the proposed special assessment district, the Township Board of Trustees may not proceed to make the improvements unless it first receives a petition requesting the improvements signed by the record owners of land constituting more than 50% of the total frontage upon the roads being improved in the proposed special assessment district.
